

# 7-year-old Brazilian Boy Died After First Pfizer COVID-19 mRNA Vaccine

His little heart destroyed with inflammation and clots

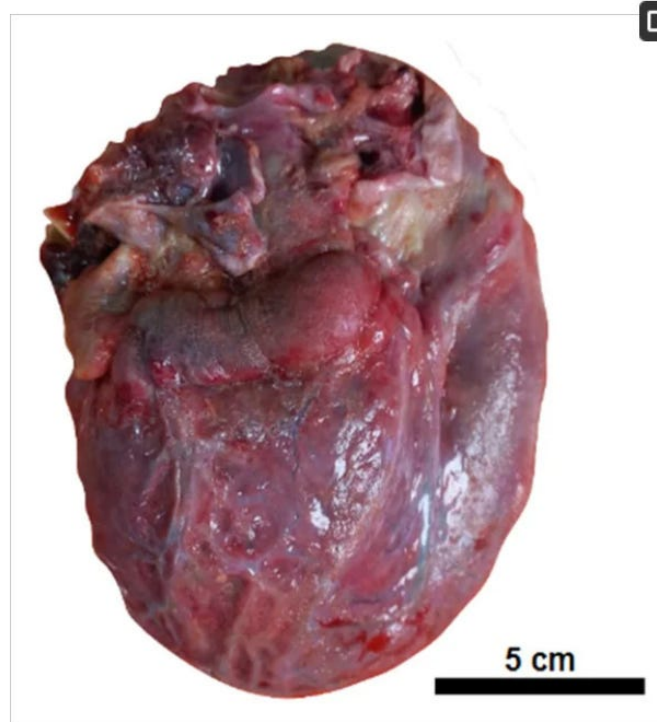

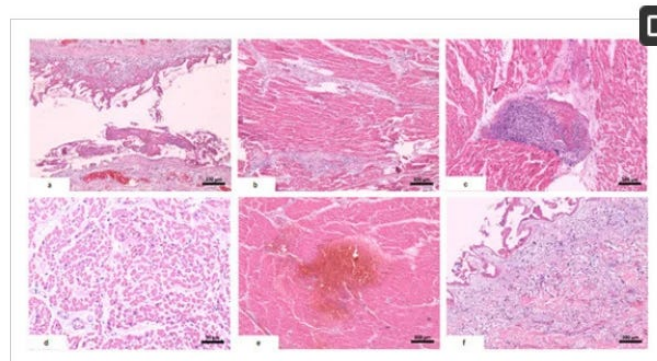

On autopsy, external examination showed anasarca and increased abdominal volume. The internal organs showed diffuse edema, including the brain, with pleural, pericardial, and peritoneal cavity effusion. The heart exhibited a granular, opaque, whitish external surface, akin to fibrin deposits on the pericardium (Figure 1).



**Figure 1.** Pericarditis. Globose heart with an opaque external surface covered in fine granulation and fibrinous debris.

The myocardium had a soft consistency, alternating between pale and hemorrhagic areas, while the valves remained preserved. [Microscopy revealed disseminated vascular thromboembolism](#). The macroscopic and microscopic findings of the main organs are reported below (Table 2, Figure 2, Figure 3 and Figure 4).

## Abstract

Carditis in childhood is a rare disease with several etiologies. We report a case of infant death due to pericarditis and myocarditis after the mRNA vaccine against COVID-19 (COVIDmRNAV). A 7-year-old male child received the first dose of the COVIDmRNAV and presented with monoarthritis and a fever non-responsive to oral antibiotics. The laboratory investigation showed signs of infection (leukocytosis, high levels of c-reactive protein). His condition rapidly deteriorated, and the patient died. The autopsy identified pericardial fibrin deposits, hemorrhagic areas in the myocardium, and normal valves. A diffuse intermyocardial inflammatory infiltrate composed of T CD8+ lymphocytes and histiocytes was identified. An antistreptolysin O (ASO) dosage showed high titers. The presence of arthritis, elevated ASO, and carditis fulfills the criteria for rheumatic fever. However, valve disease and Aschoff's nodules, present in 90% of rheumatic carditis cases, were absent in this case. The temporal correlation with mRNA vaccination prompted its inclusion as one of the etiologies. In cases of myocardial damage related to COVID-19mRNAV, it appears to be related to the expression of exosomes and lipid nanoparticles, leading to a cytokine storm. The potential effects of the COVID-19mRNAV must be considered in the pathogenesis of this disease, whether as an etiology or a contributing factor to a previously initiated myocardial injury.

## 2. Case Report

A 7-year-old male child presented with myalgia and fever 3 days after receiving the first dose of the COVID-19 vaccine (BNT162b2). The parents denied previous contact with sick people or a history of symptoms of upper airway infection. After seven days, he presented with monoarthritis in his right ankle. Blood tests indicated leukocytosis, but a CT scan of the ankle showed no abnormalities. He was diagnosed with septic arthritis and discharged with empirical antibiotic therapy.

After 10 days, the patient was re-evaluated due to persistent symptoms. At this time, leukocytosis had improved, and O antistreptolysin (OAS) values were normal, leading to discharge with a new outpatient antibiotic regimen. Three weeks post-symptom onset, with ongoing joint pain and walking difficulty, new tests were performed. Elevated OAS levels prompted hospital admission for intravenous antibiotic treatment with oxacillin. The joint pain improved over nine days, but the patient developed mild gastrointestinal symptoms like vomiting with blood streaks and epigastric pain. His condition rapidly deteriorated upon diagnosis of upper gastrointestinal bleeding. Post-oro-tracheal intubation, active bleeding was observed from the tube, leading to an emergency department referral. Laboratory tests indicated leukocytosis, elevated C-reactive protein levels, and negative COVID-19 polymerase chain reaction (Table 1), alongside right upper and lower lung lobe consolidations and ground-glass opacities on chest CT. Unfortunately, the patient died.

## Summary

A 7 year old Brazilian boy had a Pfizer COVID-19 mRNA Vaccine. 3 days later he had muscle pain and 7 days later he presented with arthritis in his right ankle.

He was diagnosed with septic arthritis and sent home with antibiotics.

He presented again 10 days after jab with persistent symptoms and was sent home again with a new antibiotic regimen.

He presented again 3 weeks after jab with joint pain and difficulty walking, and was hospitalized and put on IV antibiotics, but 9 days into hospitalization, he developed gastrointestinal bleeding, deteriorated rapidly, had to be intubated, developed lung consolidations and died.

Autopsy showed myocarditis, pericarditis, and “disseminated vascular thromboembolism” (disseminated blood clots).

This is the youngest case published to date, with autopsy proven COVID-19 mRNA Vaccine

damage leading to death.

Notice however, that although his heart was destroyed by the Pfizer vaccine, he didn't present with cardiac symptoms.

CLEVELAND, Ohio (WOIO) - The parents of 4-year-old Maisie said she has long road to recovery after symptoms from a common cold took a turn for the worse.

The preschooler's parents took her to an urgent care after she came down with a stuffy nose and cough, last week.

"We got told it was just a common cold, just take her home, lots of fluids, and things of that nature," Patric Schmidt, Maisie's dad, said.

By Saturday, her symptoms quickly worsened.

Maisie was lethargic, so her parents brought her to the emergency room near their home in Strongsville, then to Rainbow Babies and Children's Hospital.

"It's not what you expect," Schmidt said. "We just thought it was a common cold and that we'd be taking her home the same day never thought we'd be down here."

Not long after arriving at the hospital, Schmidt said Maisie was put into a medically induced coma.

On Monday, doctors found she had suffered a stroke.

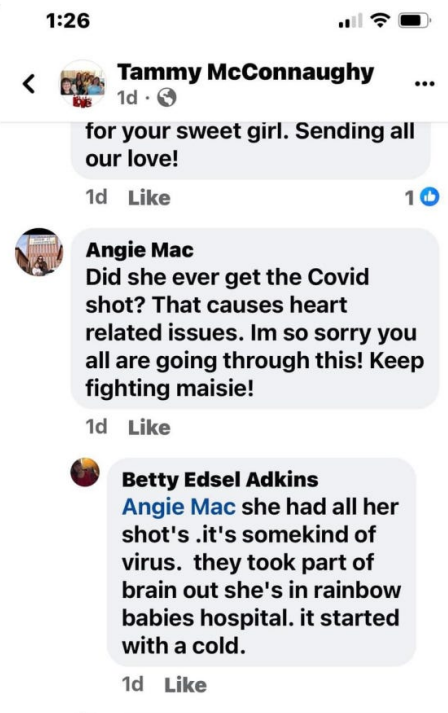

The 4-year-old was quickly brought in for brain surgery shortly after.

Following a test on Monday, doctors had discovered that the four-year-old had suffered a stroke. The dad explained: "She went in for a CT scan. They said that there was some bleeding on the brain, so they wanted to get a scan of that and in the process of doing so they found that she actually had a very large stroke on the right side of her brain."

The swelling in her brain had become so severe that part of it had to be removed in an attempt to save her life, Patric said. "She is one of the most lovable people that you'll ever meet," he added. "She's so smart and so willing to help anyone and she wants everyone to love her just like she loves everyone else."

Maisie was expected to stay hooked up to life support machines and stay in a medical-induced coma for "several months", according to a post on a [GoFundMe](#) campaign set up to support the family.

Now, in a tragic update on the campaign page on Tuesday morning, Maisie's uncle announced that the little girl had passed away. "I wish I could deliver a happy ending to this story," wrote Mike.

The family of a young girl who was about to start a new school year has been left devastated by her sudden death after she suffered a brain bleed and died in her sleep.

Zali June Breitkreutz died at home in Townsville in North Queensland last Monday.

The eight-year-old was due to start Year 4 at St Anthony's Catholic College this month.

It's understood Zali complained of a mild headache on the day of her death but showed no other symptoms.

Her cause of death was determined to be a type of stroke known as an intracerebral haemorrhage.

Her devastated family are preparing for her funeral which will be held at The Lakes Chapel at Morley's Funeral Home in West End on Thursday at 2pm.

Mr Breitkreutz said Zali showed no signs that she had any symptoms of the deadly condition.

'There was nothing that could be done, no symptoms, just a minor headache,' he told Daily Mail.

Attendees of Zali's funeral have been asked to wear something bright to the service and a wake will be held at the Brothers Leagues Club in Kirwan from 5pm.

Intracerebral haemorrhage is a type of bleeding in the brain tissue which is caused by high blood pressure.

The condition causes blood to be released into the brain, eventually leading to a stroke.

The disease can be treated by removing a clot that forms in the brain, reducing the amount of pressure that is built up.


However, the damage caused by the illness can be long term.

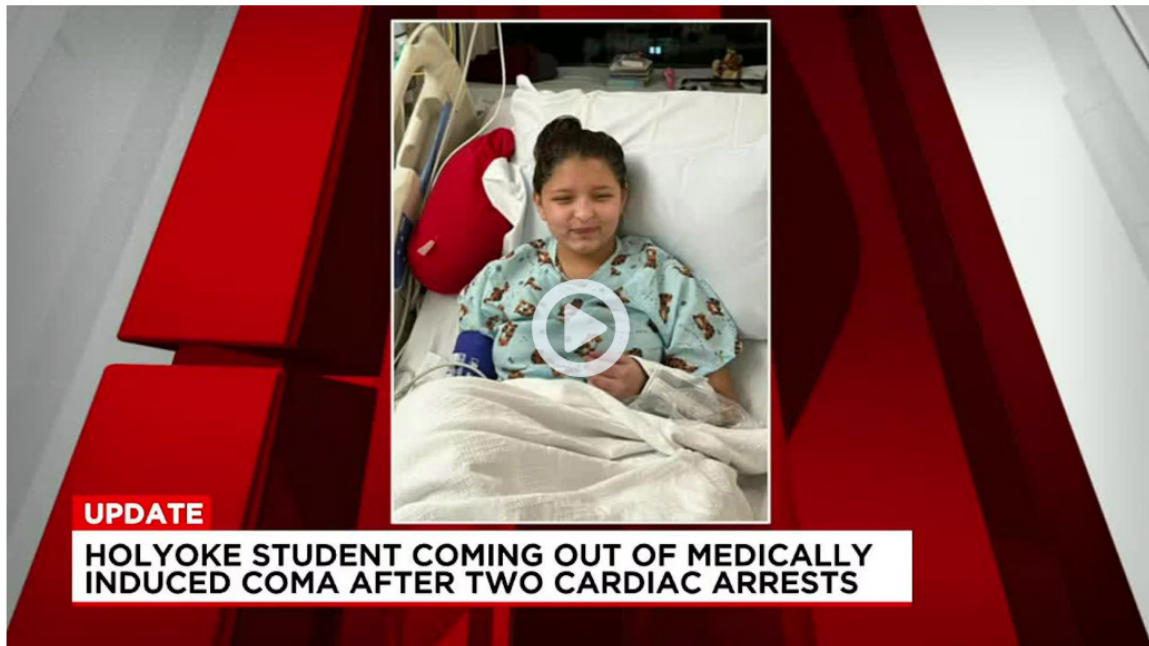

After Nevaeh Vieira spent four days in a medically induced coma, her mother, Krissy, told Western Mass News that her daughter is expected to make a full recovery. [The seventh grader collapsed in her mother's bedroom last weekend after complaining of chest pains. She suffered from two cardiac arrests and was placed into a medically induced coma for four days so that her body could recover](#)

After collapsing, Vieira's mother quickly sprung into action and began administering chest compressions until the EMTs arrived. It's an act that pediatrician Dr. John Kelley said probably saved her life.

"Having an immediate response like that within minutes of the event is absolutely crucial...If you have no circulation to the brain for five minutes or more, it's very unlikely you're going to get the person back," Kelley explained.

Western Mass News asked Kelley about the importance of cardiopulmonary resuscitation, more commonly known as CPR.

I look forward to your immediate attention to this urgent matter.



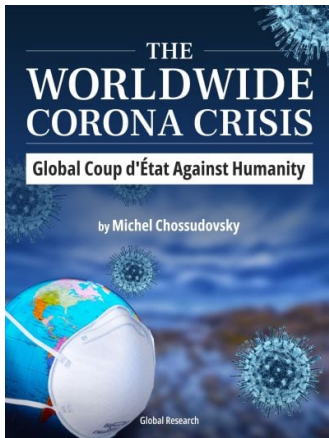
