Luckily, the news anchors knew who did it <u>within minutes</u>, the pundits knew <u>within hours</u>, the Administration knew <u>within the day</u>, and the evidence <u>literally fell</u> into the FBI's lap. But for some reason a bunch of <u>crazy conspiracy theorists</u> demanded an investigation into the greatest attack on American soil in history.

The investigation was <u>delayed</u>, <u>underfunded</u>, <u>set up to fail</u>, a <u>conflict of interest</u> and a <u>cover up</u> from start to finish. It was <u>based on testimony</u> extracted through <u>torture</u>, the records of which were <u>destroyed</u>.

It failed to mention the existence of <u>WTC7</u>, <u>Able Danger</u>, <u>Ptech</u>, <u>Sibel Edmonds</u>, <u>OBL and the CIA</u>, and <u>the drills</u> of hijacked aircraft being flown into buildings that were being simulated at the precise same time that those events were actually happening.

It was lied to by the <u>Pentagon</u>, the <u>CIA</u>, the <u>Bush Administration</u> and as for Bush and Cheney...well, no one knows what they told it because they testified <u>in secret</u>, <u>off the record</u>, <u>not under oath</u> and <u>behind closed doors</u>. It didn't bother to look at who funded the attacks because that question is of "<u>little practical significance</u>". Still, the 9/11 Commission did brilliantly, answering all of the questions the public had (except most of the <u>victims' family members' questions</u>) and pinned blame on all the people responsible (although no one so much as lost their job), determining the attacks were "a failure of imagination" because "I don't think anyone could envision flying airplanes into buildings " except <u>the Pentagon</u> and <u>FEMA</u> and <u>NORAD</u> and the <u>NRO</u>.

The DIA <u>destroyed 2.5 TB of data</u> on Able Danger, but that's OK because it probably wasn't important.

The SEC <u>destroyed their records</u> on the investigation into the insider trading before the attacks, but that's OK because destroying the records of the largest investigation in SEC history is just part of routine record keeping.

NIST has <u>classified the data</u> that they used for their model of WTC7's collapse, but that's OK because knowing how they made their model of that collapse would "jeopardize <u>public</u> <u>safety</u>".

The FBI <u>has argued</u> that all material related to their investigation of 9/11 should be kept secret from the public, but that's OK because the FBI probably has <u>nothing to hide</u>.

<u>This man</u> never existed, nor is anything he had to say worthy of your attention, and if you say otherwise you are a paranoid conspiracy theorist and deserve to be shunned by all of humanity. Likewise <u>him</u>, <u>him</u>, <u>him</u>, and <u>her</u>. (and <u>her</u> and <u>her</u> and <u>him</u>).

Osama Bin Laden lived in a cave fortress in the hills of Afghanistan, but somehow got away.

Then he was hiding out in Tora Bora but <u>somehow got away</u>.

Then he lived in Abottabad [Pakistan] for years, taunting the most <u>comprehensive</u> <u>intelligence dragnet</u> employing the most sophisticated technology in the history of the world for 10 years, releasing video after video with complete impunity (and getting younger and younger as he did so), before finally being found in a daring SEAL team raid which <u>wasn't</u> recorded on video, in which he <u>didn't resist</u> or <u>use his wife as a human shield</u>, and in which these crack special forces operatives panicked and killed this unarmed man, supposedly the

best source of intelligence about those dastardly terrorists on the planet.

Then they dumped his body in the ocean before telling anyone about it. Then a couple dozen of that team's members [SEAL] <u>died in a helicopter crash</u> in Afghanistan.
