

# A Move to Impeach Bush

The Politico reports:

“Rep. Dennis Kucinich (D-Ohio) introduced 35 articles of impeachment against President Bush on Monday night, reading the resolution into the Congressional Record. ... Kucinich has introduced a similar impeachment resolution against Vice President Cheney. That resolution was referred to the House Judiciary Committee, which has taken no action on the measure. Speaker Nancy Pelosi (D-Calif.) and other top House Democratic leaders have stated that there will be no consideration of impeachment proceedings against Bush, calling the idea ‘off the table.’”

Former Congresswoman Holtzman served on the House Judiciary Committee during Nixon’s impeachment hearings and co-authored the 1973 special prosecutor statute. She co-wrote (with Cynthia L. Cooper) the book “The Impeachment of George W. Bush: A Practical Guide for Concerned Citizens.” Reacting to Rep. Kucinich’s introducing articles of impeachment, she said: “Finally! The House should commence an impeachment inquiry forthwith; it is long overdue.

Kudos to Congressman Kucinich for taking this step. The recent Senate Intelligence Report goes a long way to providing a framework for impeachment on the grounds of taking us to war on false pretenses, though it did not seek to determine what the President actually knew and when he knew it.
