BUDAPEST — Ryan Crouser repeated as world champion in the shot put — and nearly broke his world record — despite recently finding two blood clots in his left leg.

“The last 20 days have been some of the most frustrating and stressful of my life,” Crouser, a two-time Olympic gold medalist and world record holder, [posted on social media Friday](#). “The medical team has been great, they explained the risks and did everything to mitigate them and left the decision to go to WC to me and my family. I made it to Budapest and will be competing.

“The medical staff has me on anticoagulant/blood thinners so that it is safe to compete and minimize the risk of it worsening.”

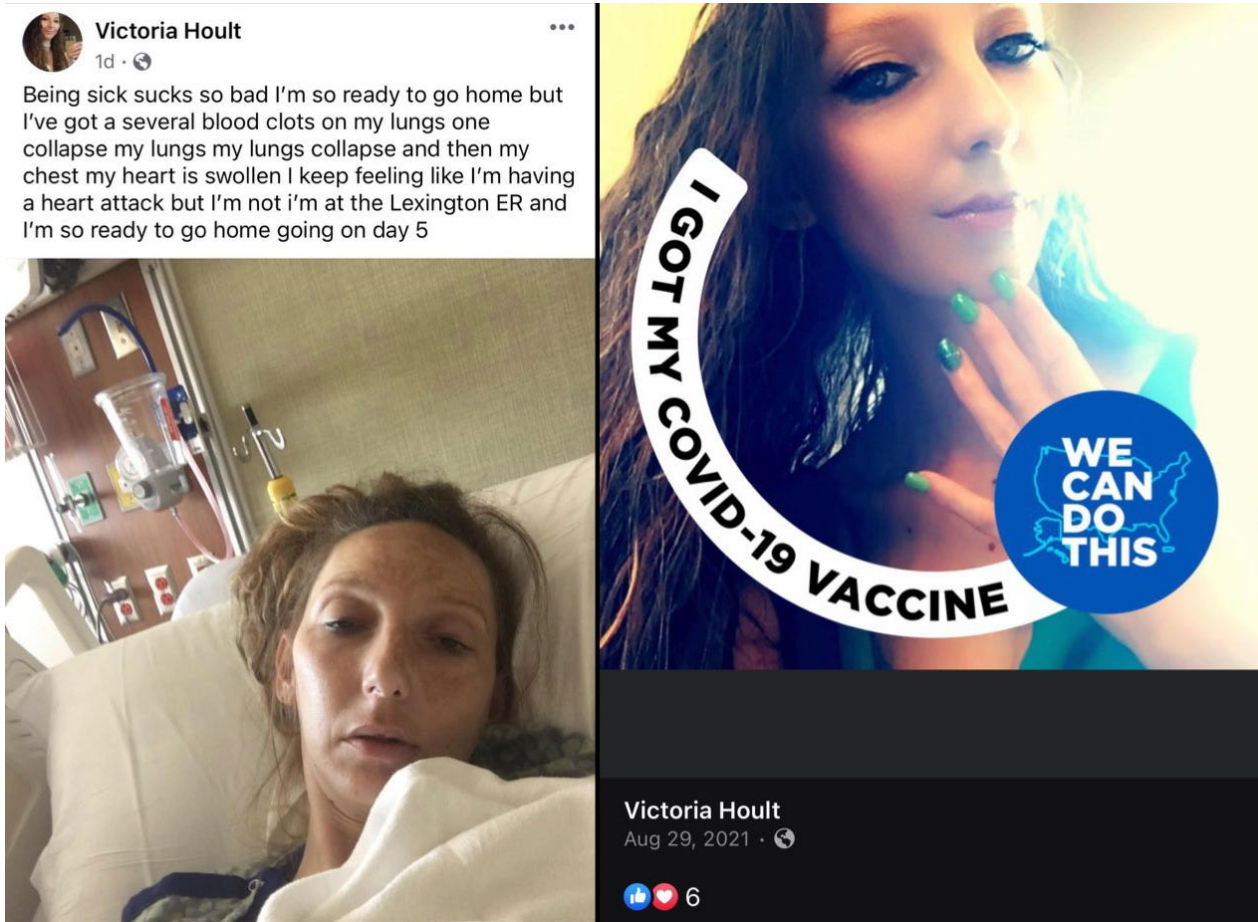

We proceeded to perform transesophageal echocardiogram which demonstrated the persistent presence of a saddle pulmonary embolism, with markedly reduced right ventricular function. Anesthesia was induced and we performed sternotomy and pulmonary embolectomy and was moved to 12 cm long bulky clots. He weaned off bypass on epinephrine at 5 and Levophed at 7 with adequate oxygenation and mild respiratory acidosis. Postoperative TEE demonstrated satisfactory right and left ventricular function.
 ESTIMATED BLOOD LOSS: 500 mL.
 DRAINS/IMPLANTS: 2 mediastinal tubes and 2 ventricular pacing wires.
 FLUIDS: Adequate.
 URINE OUTPUT: Adequate.
 SPECIMEN: Pulmonary emboli to pathology.
 COMPLICATIONS: None.
 CONDITION: Critical.
 INDICATIONS AND HISTORY: [REDACTED] is a 59-year-old male who presented with acute onset dyspnea and chest pain to [REDACTED] hospital. He was found to have massive saddle pulmonary embolism and thrombolytics were administered. He was transferred to [REDACTED] but had persistent shock and severe RV dysfunction. Surgical treatment was recommended. Risks and benefits were discussed with the patient. The patient understands and wishes to proceed with surgery.
 DESCRIPTION OF OPERATION: The patient was identified, and the procedure was verified. The patient's abdomen, chest, and groins were prepped and draped in standard fashion. Time out performed. An oblique incision was made in the right groin after infiltration with local anesthetic. Dissection was carried down and the right common femoral artery and common femoral vein were exposed. Pursestring sutures were placed and he was fully heparinized. The artery and vein were cannulated using fluoroscopic guidance and bypass was initiated. TEE was performed and a persistent pulmonary embolism of the saddle type was identified. General anesthesia was induced. An incision was made and sternotomy performed. The pericardium was opened and suspended. Epicardial ultrasound was performed with the findings noted above. Additional heparin was administered to an ACT over 400 seconds.
 The superior vena cava was dissected free from the pericardium and cannulated through pursestring suture. The main pulmonary artery was opened longitudinally and the saddle clot was obvious. It was removed, and largely extruded from the right side. The left pulmonary artery had a huge clot at the first pulmonary artery branch, and this was removed in a second large piece. I aggressively suctioned the left pulmonary artery and irrigated it, but got no more clots. I could see the first two branches of the left PA, and no visible clot was remaining. I mobilized the SVC and opened the right pulmonary artery. I could visualize the apical and posterior branches through the opening, but no clots were present. I aggressively suctioned and irrigated but no more clots were removed. The two pulmonary arteriotomies were closed with running 4-0 prolene after deairing. The patient weaned from bypass on levophed and epinephrine infusions and moderately high ventilator settings. We observed for a prolonged period of time and hemodynamics remained satisfactory and we were able to wean FIO2 to a satisfactory 70%. The femoral artery and femoral vein cannulae were removed. The arteriotomy was closed with interrupted 5-0 prolene sutures and deaired prior to closure. The vein was closed with a pursestring. Protamine was administered. Excellent hemostasis was obtained. The chest was closed in my routine fashion over 2 chest tubes and 2 ventricular pacing wires. The patient tolerated procedure well, was in the operating room at this time.





Hi, my name is Jennifer and I am fundraising for my sweet sister, Ashley.

She never asks for help and I know everyone says that, but Ashley is always the first one to help someone in need. She was diagnosed with Crohn's and ulcerative colitis in June. She started Remicade infusions earlier this month for treatment. She started having pain in her left leg and was diagnosed with a blood clot; two days later and another trip to the emergency room, her doctor found that it traveled to her lungs.

They started her on blood thinners, but those caused a whole different set of issues with bleeding due to the Crohn's and Colitis. She was admitted to the hospital then, to watch her hemoglobin because it was continuing to drop. She was very close to having a blood transfusion. The doctors decided to take her off blood thinners and put in an *IVC filter in hopes to stop anymore blood clots traveling to her lungs and heart. The IVC filter now has blood around it that her doctors are monitoring. On top of all of that she also has fluid around her kidneys and the doctors are still working to find out where that is coming from. She has her next infusion for Remicade on August 9th.

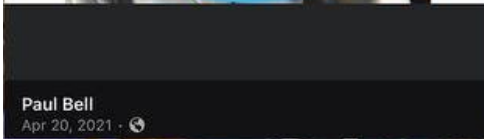

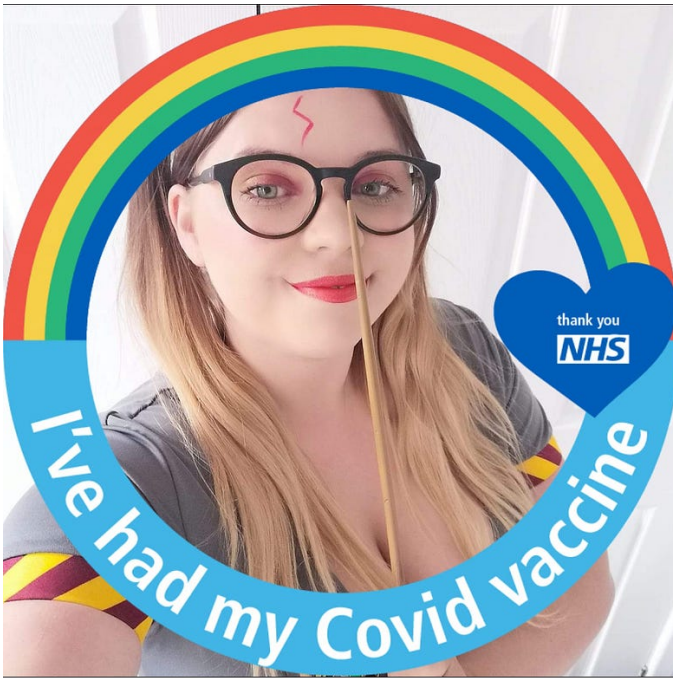

Ashley Foster is a wife, mom to 3 littles, works full-time as a CNA, and a dedicated LPN nursing student. I'm honored to call her my friend since we started the part-time

However, back in May, she started experiencing some leg pain that would not let up. This was the beginning of her health emergency. She was diagnosed with Phlegmasia Cerulia Dolens (PCD), which is partly characterized by severe blood clots. More recently, she had a life-threatening pulmonary embolism due to a complication of her PCD.

She has accumulated massive medical expenses due to multiple hospitalizations and procedures, including emergency transport by Air Evac life flight helicopter. During her most recent hospitalization, their car was broken into in St. Louis, adding to their stress even more.

Ashley has been unable to work during this time as she heals and recovers and STILL is trying to keep up with the demands of finishing her degree this summer. Doctors are still unsure what's caused her condition and more testing and procedures are inevitably ahead.

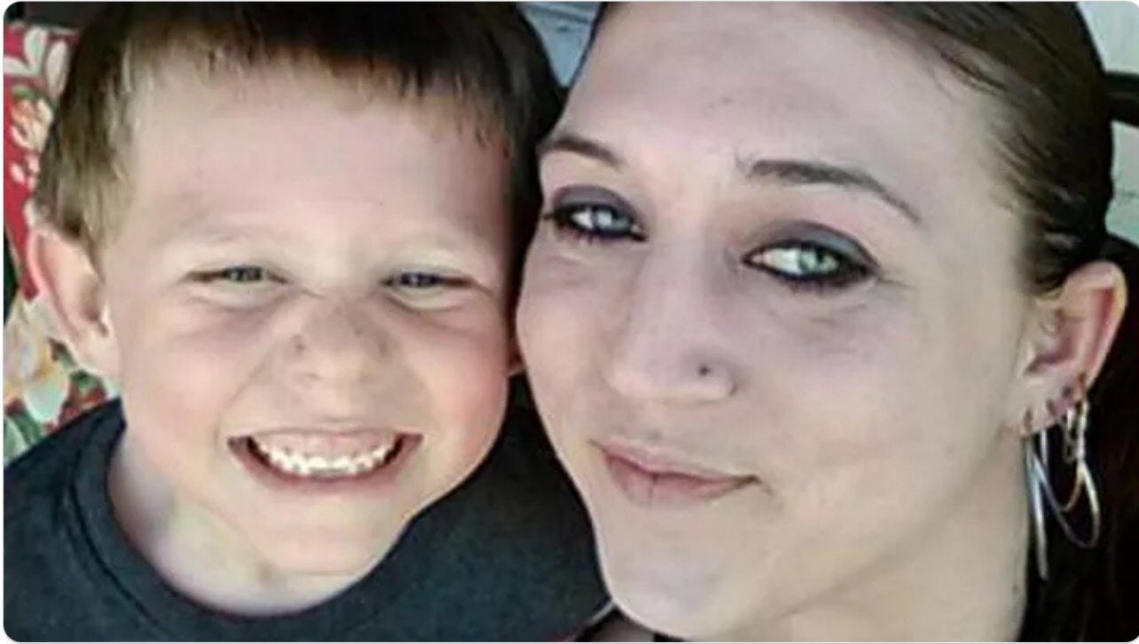

Nov. 8, 2022 - UK Actress, 30 year old Emily Chesterton, had blood clots in her legs, went to see a doctor and was told by a physician associate she had anxiety. She died of pulmonary embolism a week later.



The mother of a woman who died after a misdiagnosis by an NHS worker she mistakenly believed was a GP has called for better patient protection.

Emily Chesterton, from Salford, died after being seen twice by a physician associate, a role which the NHS said supports doctors in diagnosis.

The 30-year-old, who lived in London, was told her calf pain was a sprain, when she actually had a blood clot.

Her mother Marion said more regulation was needed around physician associates.

The actress, who was originally from Worsley, went to The Vale Practice in Crouch End in October 2022.

She believed she was speaking to a GP about her symptoms, but instead saw a physician associate, who gave a diagnosis of a sprained ankle.

She returned in November and highlighted her additional symptoms of shortness of breath and a swollen and hot leg.

At that appointment, the physician associate prescribed anxiety medication.

Ms Chesterton collapsed later that day and died in hospital on 8 November, three weeks after she first sought medical advice.

At her inquest in March, the coroner concluded that after presenting with her symptoms, she "should have been immediately referred to a hospital emergency unit".

They said it was likely that she would have then been "treated for pulmonary embolism and would have survived".

In late March, Ezarik had noticed her arm was feeling numb but it wasn't until April 1 that the 38-year-old was rushed to the hospital after it started swelling and turning purple.
