# Deion Sanders recovering after successful emergency surgery to repair blood clots in legs

Colorado football coach Deion Sanders is recovering after emergency surgery to treat persistent blood clots in his legs he announced in a video posted Saturday. The procedure was to correct blood-flow issues that have plagued Sanders dating back to his days coaching at Jackson State.

In the Instagram video, Sanders told his sons he expects to be released on Sunday, just two days after Friday's procedure.

"I had a big blood clot in my thigh that they got out, and I had some below my knee that they got out," Sanders said from his hospital bed. "Then I've got one in the right leg that they're going to get soon."

July 1, 2023 - 45 yo actor Tyler Labine is recovering from a stomach ache that **"turns out to be a potentially fatal blood clot in your intestines and liver and you have to spend the next 3 days in the hospital trying not to die"** (he was fully COVID-19 vaccinated)

Evil* even though he spent five seasons on NBC doctor show *New Amsterdam*, has had what sounds like a pretty painful and frightening week after realizing he had a "potentially fatal blood clot" impacting his "intestines and liver." Labine posted about the experience on Instagram (via *Deadline*), complete with a video showing himself in a hospital gown and riding in an ambulance.



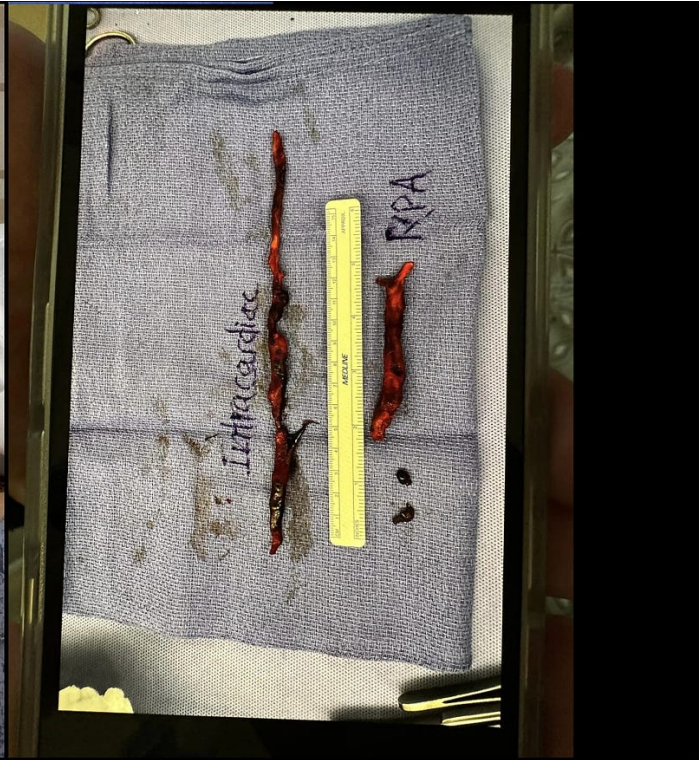

May 25, 2023 - Hartford, CT - Kristen Ann Mallinson, a business major, had Pfizer COVID-19 mRNA vaccines with 3 boosters. She was hospitalized 11 days with blood clots in lungs and heart, with a 6" blood clot in the heart (picture below). She regrets getting vaccines ([click here](#))

11 days in the hospital. 2 emergency surgeries. 1 blood transfusion. The first picture are the blood clots on my lungs. Then they found out I was allergic to Heparin, the primary blood thinner used for PEs. I formed a heparin induced thrombocytopenia pf4 antibody, meaning my body rejected the blood thinner and made more clots (basically fighting the heparin drug). A large clot traveled into the left and right chambers of the heart where they realized I was born with a hole in my heart. Usually it is closed where a blood clot won't travel to the left chamber. If it broke off it would go straight to my brain causing a stroke. This called for emergency open heart surgery. [The second picture shows the blood clot on my heart being over 6"](#)

I am now 5 weeks post OHS. I'm physically getting stronger but mentally still shocked. Joined to have a better support system!

She had been staying there while recovering from surgery for a broken leg several weeks earlier.

Dani's mum Kay desperately performed [CPR](#) but she could not be saved.

Doctors believe a blood clot from the operation on her leg travelled to her lung, causing a [pulmonary embolism](#) - or blocked artery.

Dani's aunt Sharon Glover described her niece as her "darling girl".

She said alongside a photo of the two of them: "Of all the many blessings I've had in this world, the greatest one was the honour of being your aunt.

"The tears on my face I can wipe away but the ache in my heart will last forever.

"Fly high my darling girl. Love you always."

Dani, from [Brisbane, Australia](#), had just bought a house in Albion and said she was "so excited and nervous to start this new chapter".

Feb. 1, 2023 - Willington, UK - 20 year old footballer Levi Dewey went to hospital with flu symptoms, then suffered severe sepsis and had to have both legs amputated after suffering multiple organ failure ([click here](#))



Jan. 1, 2023 - UK Piano Teacher Julianna Bransden suffered catastrophic injuries after COVID-19 vaccines ([click here](#))





**Julianna was fully COVID-19 vaccinated.** On Dec. 23, 2022 she developed flu like symptoms and on Jan. 1, 2023 she had **two cardiac arrests, went into septic shock, multiple systemic organ failure, needing full life support.**

**That's over 100,000 reported blood clot events in one adverse event reporting system. Apply an under-reporting factor of 10x or 100x and that means there are between 1 million and 10 million COVID-19 vaccinated people with blood clots.**

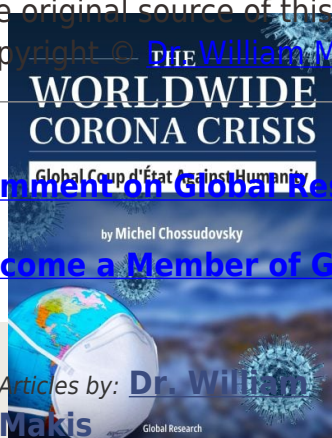
