A devastated family has been 'torn apart' after their 11-year-old daughter died from the flu, as warnings intensify over the dangers of influenza B among young children this winter.

Emma Schwab, 11, from Noosa on **Queensland**'s Sunshine Coast, died last Thursday after contracting Influenza B.

A **GoFundMe page**, set up by a friend of the girl's parents to cover her funeral costs, has so far raised almost \$9,000.

'She was only 11 years old. Understandably the family is torn apart.'

A Sunshine Coast Hospital and Health spokesperson, where Emma was treated, offered 'sincere sympathies to the family during this extremely difficult time'.

'Their experience is heartbreaking for everyone involved,' they said.

'Our clinicians are providing support to the family.'

mma's death comes after a teenage girl from the Central Coast also died after contracting influenza B.

The Year 9 student attended St Joseph's Catholic College in East Gosford and passed away on the weekend after falling ill with the disease several weeks ago.

Parents with children at the school received a letter informing them of the girl's tragic death, according to the **ABC**.

'(She) was a well-loved student, thoughtful to the needs of others, a true friend and a valued member of our college community,' the letter read.

Feb. 23, 2023 - IL - 7 year old Rose Tylor Kunkes died suddenly from Strep Throat.

<u>Feb. 17, 2023</u> – UK – 6 year old Milly-Rose Stirrup suddenly fell ill on Feb. 14 with pain in her stomach and her heart. Within a few days she was dead. Doctors suspect sepsis.





Family's tragedy as girl dies hours after experiencing belly ache

"Milly-Rose made an impression on everyone. She was an angel sent from above."

A little girl has died suddenly of sepsis hours after complaining her belly ached.

Milly-Rose Stirrup, six, was off school with a bug but told her parents Shaun and Pip her stomach and head hurt.

She had been enjoying an ice lolly and playing on her Nintendo Switch but suddenly fell ill.

Her mum and dad took her to the hospital, where they held her hand as she was hooked up to antibiotics and discussed what they would do once she was well enough to go home.

But, tragically, she never returned home.

Just a few hours after being admitted to Manchester Children's Hospital, Milly-Rose was pronounced dead.

The cause of her rapid deterioration has not been formally confirmed, but doctors believe she was suffering from sepsis, reports Manchester Evening

Milly-Rose, who was said to "love life" and would "light up any room" came home from school last Tuesday, 14 February, feeling unwell.

Her parents suspected she had caught a 24-hour stomach bug which was doing the rounds.

Shaun said: "She started being sick so we kept her off school the following day and she was just playing on her Nintendo Switch doing what kids do when they aren't well.

"She went to bed on Wednesday night and woke up on Thursday morning at 1am saying her belly was sore and her heart.

"I felt her heart and it was beating out of her chest.

<u>Dec. 20, 2022</u> – Utah – 17 year old student in a boarding school for troubled teens, Taylor Goodridge, died of peritonitis and sepsis which caused her organs to fail. She started having symptoms on Dec. 9, back pain, difficulty breathing, vomiting.



Father sues Utah boarding school for malpractice after daughter's death

The father of a teenage girl who died at a boarding school in Utah is suing the facility, which he alleges ignored his daughter's severe pain weeks before her death. FOX 13 Salt Lake City reports.


A 17-year-old student at a "therapeutic boarding school" in Utah died of sepsis after school staff ignored her health complaints, according to recent autopsy results and a lawsuit filed on behalf of the deceased student and her family.

Taylor Goodridge died of peritonitis, an infection of abdomen tissue, followed by sepsis, which caused her organs to fail, in December 2022 at <u>Diamond Ranch Academy</u> in Utah.

"It's something that's easily treated with antibiotics, especially with a healthy 17-year-old," attorney Alan W. Mortensen of Mortensen and Miline told Fox News Digital. "The first signs of peritonitis are vomiting and stomach cramps, both of which Taylor had for... at least two-and-a-half weeks before she died. She was never taken to the hospital. Her complaints were ignored, and she was punished for making the complaints."

The infection eventually spread to her heart, liver, kidney and pancreas, said Mortensen, citing the Utah Medical Examiner's autopsy results.

<u>Dec. 13, 2022</u> - 18 year old Maria Alexandra Gaynor was a healthy student at Dalhousie University, which mandated COVID-19 mRNA vaccines on all students. She died suddenly of Meningitis.

Ayla Grace Loseth was taken to hospital by her parents Chrissy and Brad on Nov. 26, 2022 with dehydration, nausea and fever. They were told it was the flu but, three days later, she died from sepsis from Strep A. (Click here)

THE first results of the autopsy ordered on the body of Lorenzo Squillace, the healthy young lifeguard from San Benedetto del Tronto in Italy who died suddenly at the age of 18, have been made available to Italian media outlets.

UPDATE 5.08 pm (September 15) – Following the death of the lifeguard from San Benedetto del Tronto, who died suddenly on Saturday, September 10, an autopsy was ordered by the public prosecutor's office.

According to the first results of the autopsy examination, Mr Squillace appears to have had a blood infection which, as the forensic doctors confirmed, was realised too late, as reported by *bigodino.it* on Thursday, September 15.

Aug. 23, 2022 – Naples, Italy – 19 year old Greek female navy cadet Talia who was on board Prometheus ship died 48hr after feeling unwell on Aug. 23, 2022. **She had hemorrhagic rash, then sepsis**.

Australian researchers publish study proving COVID-19 mRNA vaccines damage the immune systems of children!

Published on <u>Aug. 25, 2023</u>, the paper is called: "BNT162b2 COVID-19 vaccination in children alters cytokine responses to heterologous pathogens and Toll-like receptor agonists"

Study looked at **29 kids ages 5-11** and found that:


- "BNT162b2 vaccination is associated with a decrease in bacterial and viral stimulant-induced cytokine responses one month after vaccination"
- "BNT162b2 vaccination is associated with a sustained decrease in cytokine responses to viral, but not bacterial, stimulants six months after vaccination"
- "These data show that a SARS-CoV-2 mRNA-based vaccine alters heterologous immunity in children and that these effects can persist up to six months after vaccination"

It only took researchers 1.5 years to catch up to my warnings against mRNA vaccinating children ages 5-11.



By 5:11pm my Twitter account was locked, suspended and stayed suspended for 11 months.




Twitter would go on to suspend and terminate every doctor and scientist who raised concerns about safety of mRNA vaccines in children.

What happened 6 months later? Nov-Dec 2022: USA had worst flu season in 2 decades!


This flu season's **ferocious start** has given way to record-shattering levels of transmission — and massive strains on the American health system.

In the week ending November 26, more than 34,000 positive flu tests were reported to the Centers for Disease Control and Prevention (CDC) from labs around the US, as shown in the orange line on the chart below. That's more positive flu tests than have been reported in any single week during any flu season on record, going back as far as 1997.

The trajectory dwarfs the past six flu seasons, including the relatively bad 2019-2020 one that immediately preceded the start of the Covid-19 pandemic (shown in the black line).

The flu spread early and quickly this year

Canada also had worst flu season in years: "10 kids dead amid pediatric flu surge". "Pediatric hospitalizations were 20x higher than usual for the time of year."


