

Confidential Pfizer and Government Docs Confirm ADE, VAED, and AIDS from COVID Shots

Government documents show that the most likely cause of all of these diseases is the COVID-19 injection.

The <u>US Food and Drug Administration</u> (FDA) attempted to delay the release of Pfizer's COVID-19 vaccine safety data for 75 years despite approving the injection after only 108 days of safety review on <u>December 11th, 2020</u>.

The FDA originally said that they were prepared to release <u>500 pages per month</u> in a response to the Freedom of Information (FOI) request filed on behalf of <u>Public Health</u> and <u>Medical Professionals for Transparency</u> (PHMPT) requesting the safety data.

Instead, in early January 2022, Federal Judge Mark Pittman ordered them to release 55,000 pages per month. They released 12,000 pages by the end of January.

Since then, PHMPT has posted all of the documents to its website. -The Daily Exposé

One of the documents contained in the latest data dump is <u>'reissue_5.3.6 postmarketing</u> <u>experience.pdf'</u>. Table 5, found on page 11 of <u>the document</u> shows an 'Important Potential Risk', and that risk is listed as 'Vaccine-Associated Enhanced Disease (VAED), including Vaccine-Associated Enhanced Respiratory Disease (VAERD)'.

Gender: Females (73), Males (57), Unknown (8); Age (n=132) ranged from 21 to 100 years (mean = 57.2 years, median = 59.5); Case outcome: fatal (38), resolved/resolving (26), not resolved (65), resolved with sequelae (1), unknown (8); Of the 317 relevant events, the most frequently reported PTs (≥2%) were: Drug ineffective (135), Dyspnoea (53), Diarrhoea (30), COVID-19 pneumonia (23), Vomiting (20), Respiratory failure (8), and Seizure (7). Conclusion: VAED may present as severe or unusual clinical manifestations of COVID-19. Overall, there were 37 subjects with suspected COVID-19 and 101 subjects with confirmed COVID-19 following one or both doses of the vaccine; 75 of the 101 cases were severe, resulting in hospitalisation, disability, life-threatening consequences or death. None of the 75 cases could be definitively considered as VAED/VAERD. In this review of subjects with COVID-19 following vaccination, based on the current evidence, VAED/VAERD.	


