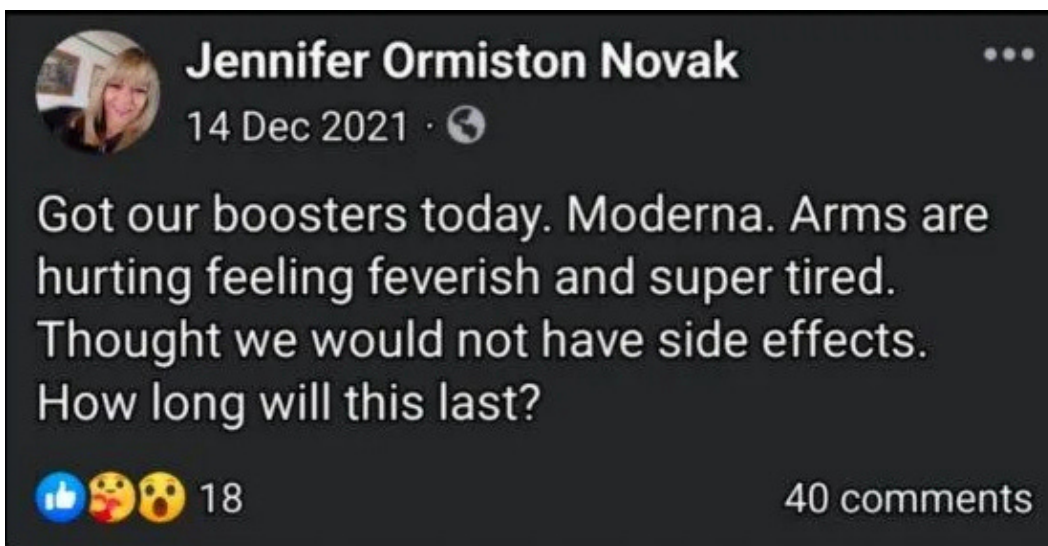

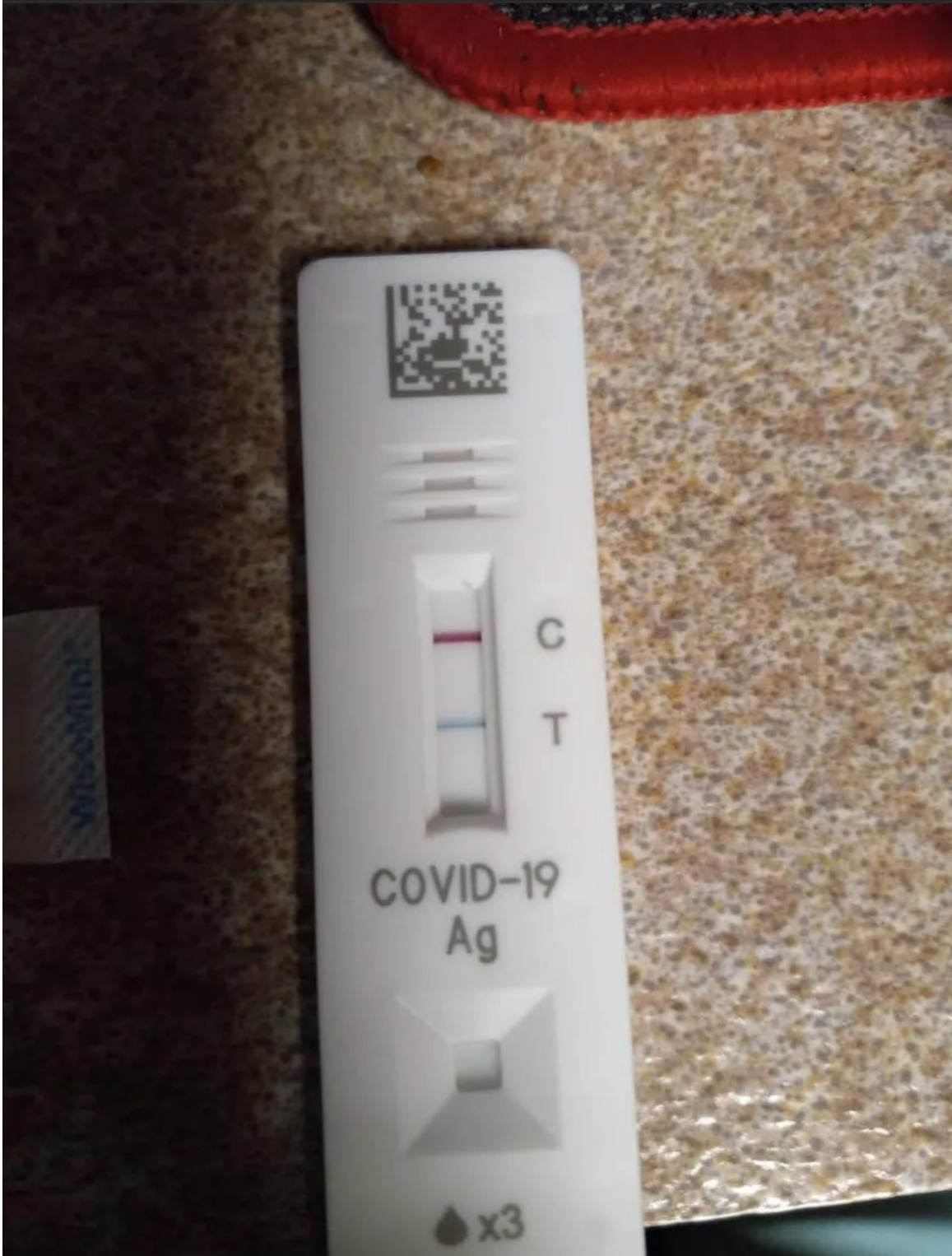

Overall, a tragic, shocking story of someone who had no idea of the toxicity of the

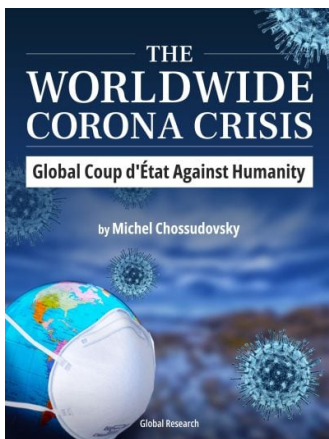
experimental pharmaceutical products she continued taking with her husband.
