Abstract

Background: Venous thromboses have been linked to several COVID-19 vaccines, but there is limited information on the Moderna vaccine's effect on the risk of arterial thrombosis. Here we describe a case of post-Moderna COVID-19 vaccination arterial infarct with vaccine-associated diffuse cortical edema that was complicated by refractory intracranial hypertension. **Case Summary:** 24 hrs after receiving her first dose of the Moderna COVID-19 vaccine, a 30-year-old female developed severe headache. Three weeks later she was admitted with subacute headache and confusion. Imaging initially showed scattered cortical thrombosis with an elevated opening pressure on lumbar puncture. An external ventricular drain was placed, but she continued to have elevated intracranial pressure. Ultimately, she required a hemicraniectomy, but intractable cerebral edema resulted in her death. Pathology was consistent with thrombosis and associated inflammatory response. **Conclusion:** Though correlational, her medical team surmised that the mRNA vaccine may have contributed to this presentation. The side effects of COVID-19 infection and vaccination are still incompletely understood. Though complications are rare, clinicians should be

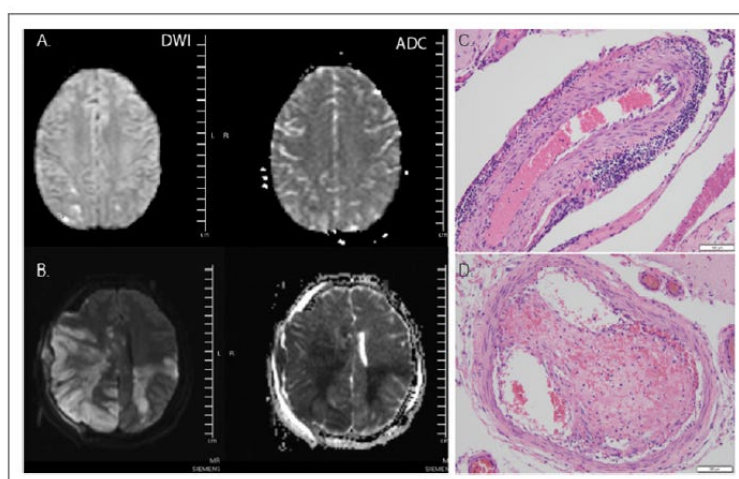


Figure 1. Imaging **A:** Representative axial MRI brain images on day of admission. **B:** Eight days after admission, left panels represent diffusion weighted (DWI) sequences and right apparent diffusion coefficient (ADC) images. **C.** Hematoxylin and eosin (H&E)-stained section of leptomenigeal vessel with lymphocytic cuff **D.** H&E-stained section of leptomenigeal blood vessel with intraluminal organizing thrombus. Scale bars =100um.

“24 hrs after receiving her first dose of the Moderna COVID-19 vaccine, a 30-year-old female developed severe headache. Three weeks later she was admitted with subacute headache and confusion. In a clinical trial, one Suspected Unexpected Serious Adverse Reaction (SUSAR) such as this would have put a pause on the entire study and an investigation into why this happened and

a call for risk mitigation measures to prevent the same complication from happening to more subjects. Ironically, this case reported at a Harvard hospital had no impact on Harvard University mandating vaccination from May 5, 2021, to [March 5, 2024](#). The FAQ/consent form signed by some of the nations brightest students made no mention of fatal cerebral ischemia and thrombosis as a direct complication of COVID-19 vaccination. I wonder if the editors of [Britannica](#) will fairly record this paradoxical and dangerous time in university history.

| Harvard University is no longer requiring students to get the COVID-19 vaccine to attend the institution.

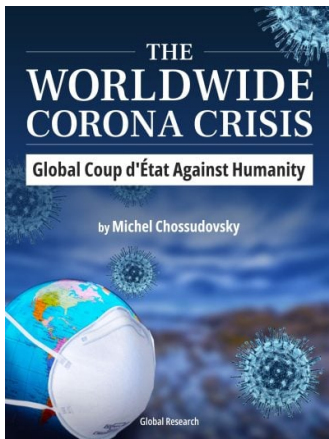
