This drops Laxalt's statewide lead from 9k to about 800 votes.

Senate candidate Blake Masters (R-AZ) also seemed to share the view that ultimately he

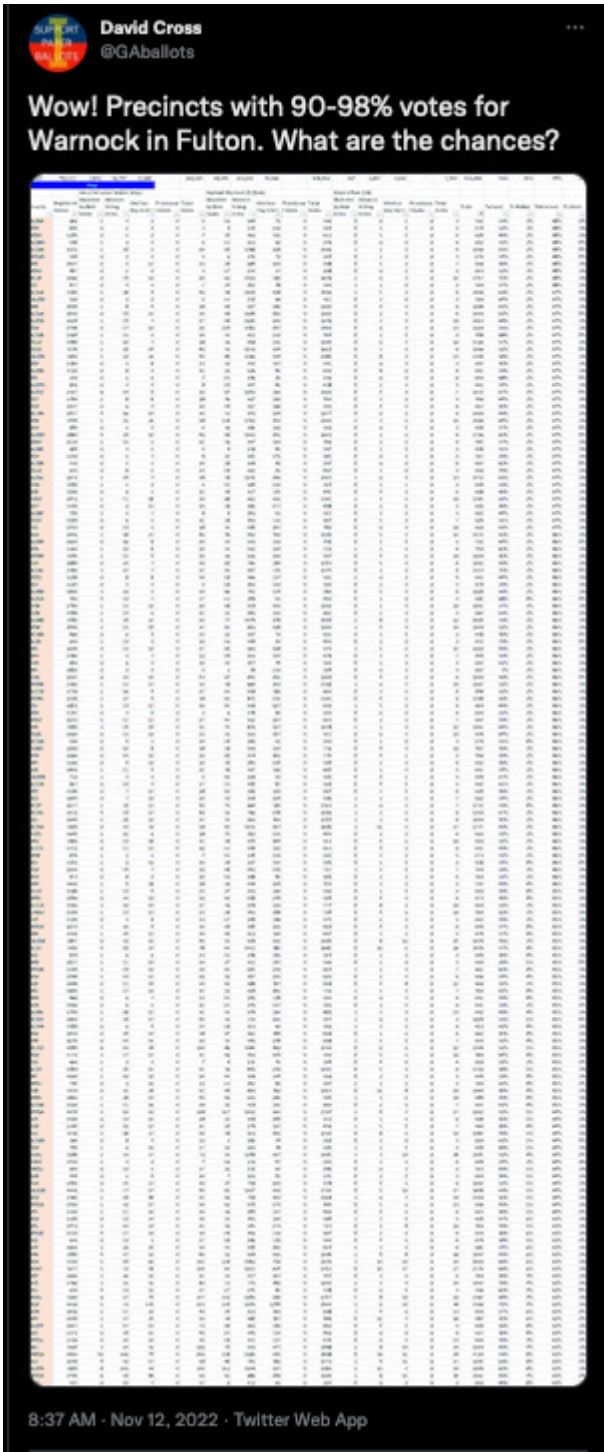
would be victorious in his race against Mark Kelly — because he too believed that the remaining 500,000 votes to be counted there *heavily favored him*.
