

Nine High School Football Players Died Suddenly in August 2024

Fans across the country are excited for a new football season, but in some places, the Friday night lights for high school football have been overshadowed by tragedy. At least seven teenage football players have died just this month. Yes, you are reading that right, in the first month of high school football seven student-athletes have already died.

In August 2024, at least seven middle and high school football players tragically died during or after practices and games across several states, including Alabama, Florida, Kansas, Maryland, Virginia, and West Virginia. These incidents have involved head injuries, suspected heatstroke, and other health emergencies related to the intense conditions of football practices in high temperatures.

One notable case involved Cohen Craddock, a 13-year-old from Madison Middle School in West Virginia, who suffered a severe head injury during practice and passed away after experiencing brain bleeding and swelling. Another player, Caden Tellier, a 16-year-old quarterback at John T. Morgan Academy in Alabama, died following a severe head injury during a game.


Other reported deaths include Javion Taylor, a 15-year-old from Hopewell High School in Virginia, who collapsed during a drill and could not be revived despite immediate CPR efforts. These tragedies have underscored ongoing concerns about player safety, particularly regarding head protection and the management of heat-related risks during practices.



While in 7th and 8th grade, he participated in Putnam Arts and Sciences (PAAS) Band and Drumline, and Pop Warner Football as a player and volunteer. RJ was the 2020 Spelling Bee School Champion at Moseley Elementary School. He was a sophomore student and avid athlete at Palatka High School. He participated in Football, Track and Field, Wrestling, and Soccer. He was a member of Mt. Tabor First Baptist Church, Palatka where he participated in the Youth and Drama Ministries. He enjoyed reading, writing, dancing, playing sports and video games, swimming, taking trips to the beach, playing the trumpet and quad drums, spending time with his family, friends and teammates, helping others, and sharpening his videography and photography skills. RJ also enjoyed traveling, attending high school and collegiate sporting events and drag racing (Gator Nationals).

NEW BROCKTON, Ala. (AP) -

A 14-year-old football player in Alabama died Tuesday after collapsing during afternoon practice.

Semaj Wilkins, a freshman at New Brockton High School, suffered a medical emergency early in practice Tuesday afternoon, Coffee County Coroner Arnold Woodham said.

Wilkins was given CPR on the field and taken to a hospital.

The cause of the teenager's death was not immediately known. The Alabama Department of Forensic Sciences will conduct an autopsy and it will likely take several weeks to receive those findings, Woodham said.

"Semaj was a young man who brought joy and inspiration to his peers, teammates, coaches, and faculty members. His loss will be deeply felt by everyone who knew him," Coffee County Schools Superintendent Kelly Cobb wrote in a statement on Facebook.

New Brockton is a town of about 1,400 people located about 80 miles (130 kilometers) south of Montgomery.

A vigil will be held Friday night at the New Brockton High School's football stadium to remember Wilkins and honor his mother.

Aug. 14, 2024 – Baltimore – 16-year-old Leslie Noble, football player, collapsed and died on August 14 after a medical emergency on the football field in Reisterstown.




HOUSTON — A grieving Houston father's fight for answers about his son's sudden death after collapsing at Marshall Middle School this week continued on Friday.

Landon Payton, 14, collapsed in the school gym on Wednesday and had multiple seizures while EMS and police officers tried to revive him. Landon was later pronounced dead at the hospital.

Alexis Payton said he spent two hours with Houston ISD leaders Friday but it was a waste of time because they wouldn't answer his questions about what happened leading up to Landon's death. He said the district showed him police body camera footage but it only showed the end of the incident.

Aug. 16, 2024 – Shawnee, KS – 15-year-old Ovet Gomez Regalado had a medical emergency after an off-season conditioning session on Wed and died on Friday Aug. 16, 2024.

"KSHB reported he was 15 years old."



(CNN) — Cohen Craddock was the baby of his family, a gregarious 13-year-old who "cared more about others than he did himself," his father Ryan Craddock said.

"He was very compassionate, very bighearted and all the time wanted to try to make you laugh, make you feel better and bring people's spirits up," Craddock told CNN.


But Cohen's West Virginia family is now left agonizing without him. The teen died Saturday after a collision during football practice Friday – marking at least the third student football player to die within the first few weeks of this school year.

Their deaths highlight the risks of the <u>America's most popular sport</u> as the country enters Labor Day weekend and football season.

Cohen's fatal injury happened the same day a 16-year-old football player from Alabama was fatally injured during his school's season opener. <u>Caden Tellier</u>, the quarterback for John T. Morgan Academy in Selma, suffered a brain injury Friday night, Alabama Independent School Association Executive Director Michael McLendon told CNN in a statement. His death was announced Saturday.


