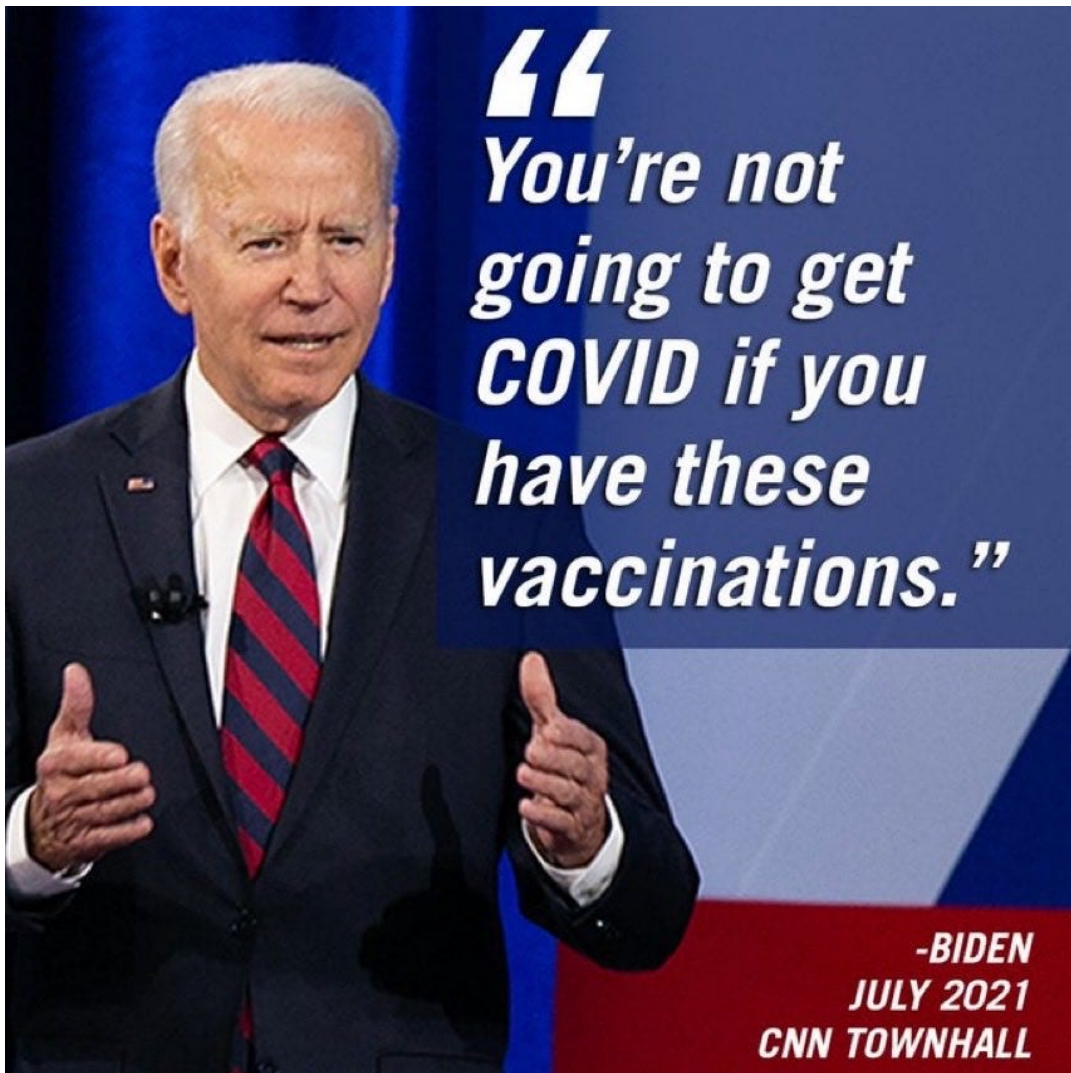

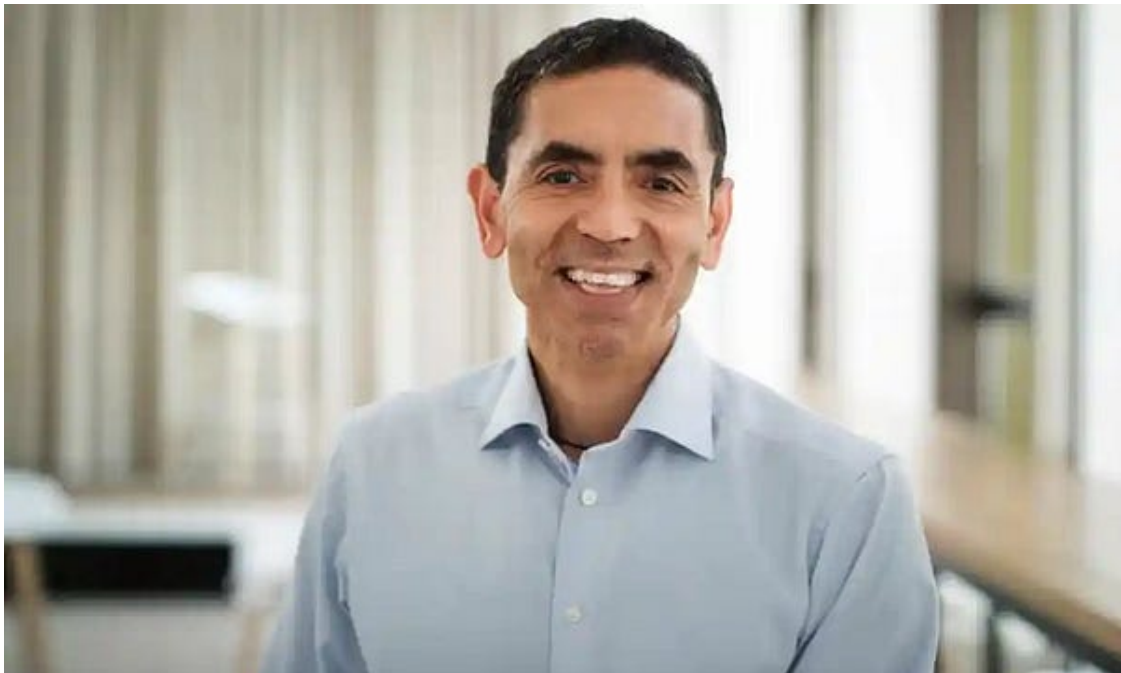

Now, why is it important to hold these people accountable?

Well, first off, they made a false proclamation and need to be held accountable for doing so.
