

Military Members and Vets Are Having Health Issues after Getting Their COVID Shots

Several military families are claiming to have been affected by these covid shots. They range from members in the earlier phases of their careers, to those retired. This article will focus on six of them, two of which are deaths.

Brooke is an active duty military member who almost lost her life and her leg after her Pfizer shot, according to her parents. [Her mother](#) Rachel Gronbach and father Greg Gronbach have both posted on social media in regards to their daughter’s experience, and it sounds pretty traumatic. Brookes experience with her Pfizer shot, has changed the course of her life.

Brooke had her shot in December then developed blood clots in her lungs. She underwent emergency surgery, and was placed in ICU. The vascular surgeon initially thought her leg would need amputated due to one of the clots that was 3” and because it had been stuck for several hours.

Brooke has undergone seven surgeries since January and has at least one or two more to go. She will be on blood thinners for the rest of her life. According to Brookes mother, Brooke’s military career is over. 2021 has been quite a setback for this once healthy 23 year old woman.

I've remained quiet for a very long time, but I feel it's time to break the silence. As some of you may recall, I asked for prayers back in January. The reason being, Brooke received the Pfizer shot late Decemeber (only one shot). She had a VERY bad adverse reaction. I was at Cbus airport on my way to her and she called telling me she had blood clots in her lungs and they were moving her to ICU. I landed in Dallas on my way to San Diego and she said they were getting ready to move her. I told her I loved her and I'd be at the hospital as soon as I landed. Well, that's when things took a turn. Mid-flight, I received a Facebook message from a stranger asking if I was her mom. I replied yes. He then called me & it was her Chief, telling me that she was in the hospital and was undergoing emergency surgery. He said "please come to the hospital immediately and I will meet you on the quarterdeck". I knew something was severely wrong. I've never prayed so hard in my life. I knew something had to have happened for Brooke to not call me to let me know anything. I arrived to the hospital and a Vascular surgeon came out and said she would probably need her left leg amputated at the groin. My heart sank. My beautiful, healthy, active, 22 year old daughter...how can this happen to her?! She had a 3" clot and had no circulation for over 13 hours. (Typically at 10 hours you lose the limb).

He said he was going to perform a bilateral fasciotomy, saying that's the 'only hope' he would have of possibly saving her leg, but he wouldn't know for some time if it would work. She was in surgery from 7pm til about 4am. She was in ICU for almost 2 weeks where they had her on the highest blood thinners possible. Constantly using a doppler on her foot to see if his surgery worked. Thankfully, he saved her leg AND LIFE that night. He is an active Captain (many years of experience) and said he has never seen someone have as many and as large of blood clots that she had throughout her body. She was then moved to a floor for a couple more weeks where she learned how to use her leg and (somewhat) walk again. When I spoke to the Cardiologist the next day, he told me she was in heart failure when they got her. The Anesthesiologist said he told both Drs he didn't feel comfortable putting her under, but at that point they had no choice. Since that day (Jan 06), she has undergone 7 surgeries (7th one today) & will have 1 or 2 more. Her career is over because she now has to be on blood thinners the rest of her life. I'm not telling you this story for pity, I'm telling you to do your research and do what's best for YOU. For those of us who DON'T want the shot, there may be more reasons than you know! **If I haven't been clear, this was all caused from the shot!! *** They have done every lab possible to rule out any other

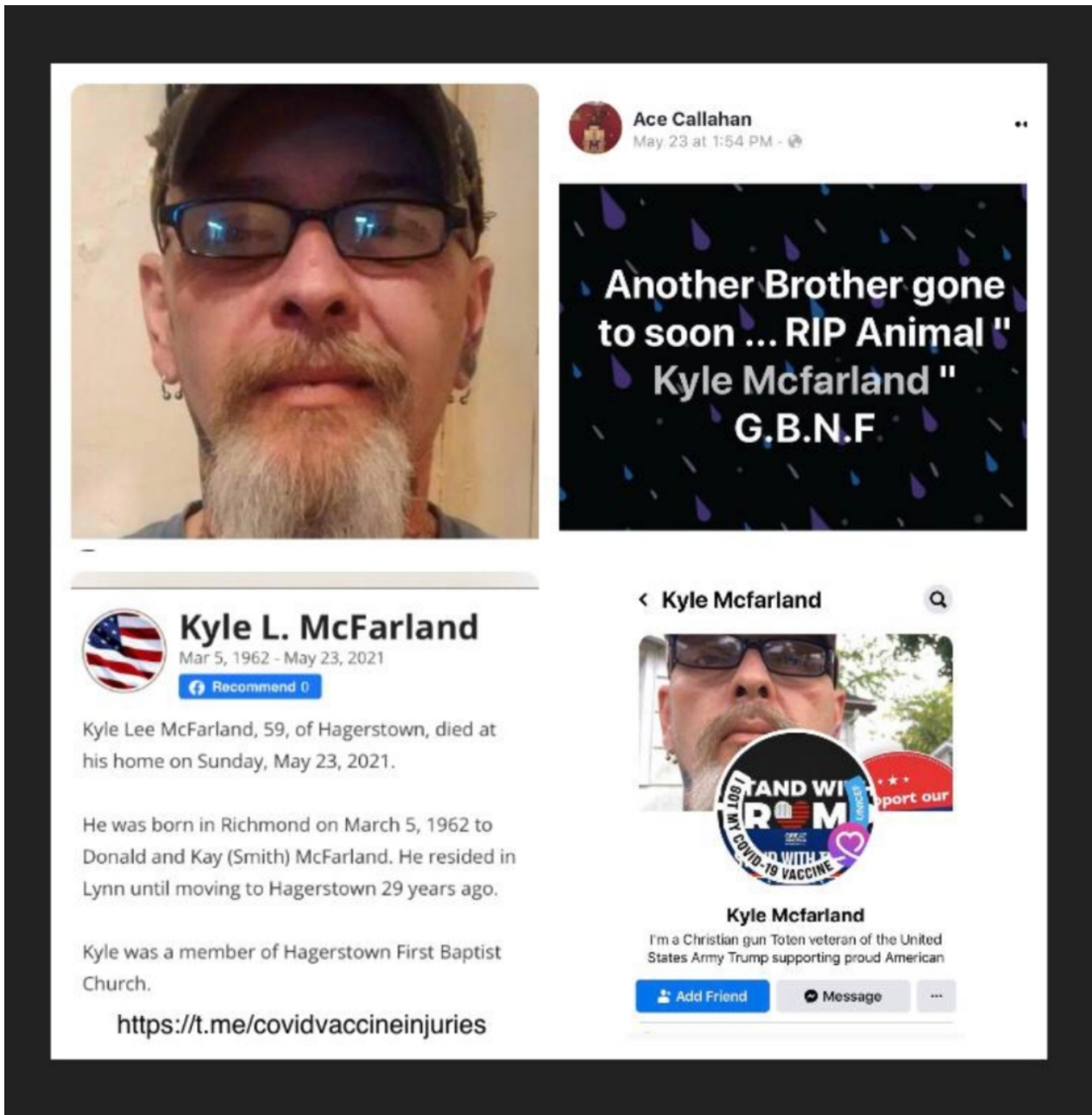
