But it is well-documented that the NSA was already spying on American Senators more than <u>40 years ago</u>.

He says the NSA started <u>spying on President Obama</u> when he was a candidate for Senate:

Another very high-level NSA whistleblower – the head of the NSA's global intelligence gathering operation – says that the NSA <u>targeted CIA chief Petraeus</u>.

Of course, the NSA also spied on the leaders of <u>Germany</u>, <u>Brazil</u> and <u>Mexico</u>, and at least <u>35</u> <u>world leaders</u> total.

The NSA also spies on the <u>European Union</u>, the <u>European Parliament</u>, the <u>G20 summit</u> and other allies.

A confidential government memo <u>admits</u> that the spying didn't help prevent terrorism:

The memo acknowledges that eavesdropping on the numbers had produced "little reportable intelligence".

Because the leaders of allies such as Germany, Brazil, Mexico, the EU and G-20 have no ties to Al Qaeda terrorists, the spying was obviously done for *other* purposes.

The NSA conducts <u>widespread industrial espionage</u> on our allies. That has nothing to do with terrorism, either. And the NSA's industrial espionage has been going on for <u>many decades</u>.

Indeed, there is <u>no evidence that mass surveillance has prevented a **single** terrorist attack.</u> On the contrary, topcounter-terror experts say that mass spying <u>actually **hurts** U.S.</u> <u>counter-terror efforts</u> (more <u>here</u> and <u>here</u>).

If NSA spying were really focused on terrorism, our allies and companies <u>wouldn't be</u> <u>fighting back so hard</u> against it.
