*In clinical practice I have seen a range of ocular pathologies in patients after COVID-19 vaccination and confirmed findings with ophthalmologists. incident conditions. It was interesting that not a single report cited an over-the-counter or prescription blood thinner as a contributing factor.

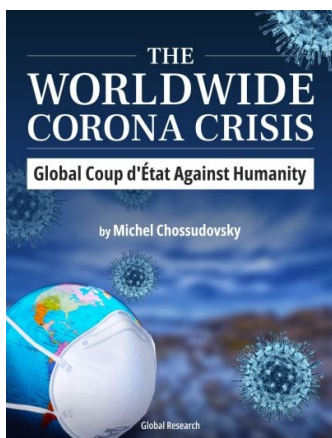
