So her husband took her to a hospital, where she was diagnosed with a brain tumor. It was cancerous.

Days later, she underwent surgery to have it removed.

Tiffany and Scott were able to make it their son’s last college hockey game.

Then, just days after that, Scott had to be rushed to a hospital.

“All of sudden, devastating right. Scott had a seizure at home and was rushed to the hospital and they discovered he had a tumor. I mean, it’s unreal,” Jones said.

Scott underwent surgery last Thursday. Jones said doctors were able to remove 90% of the tumor.

He’s back home resting. The family is waiting on the pathology results to determine his course of treatment.

On October 1, 2023, Wakefield died at his home in Massachusetts of a seizure resulting from [brain cancer](#). He was 57.^{[66][62]} The cancer diagnosis had been revealed days earlier by [Curt Schilling](#), Wakefield's former Red Sox teammate, stirring controversy because the release was not authorized by Wakefield or his family.^{[62][67]}

On February 28, 2024, his widow, Stacy Wakefield, died from [pancreatic cancer](#).^[68]

He continued: "[Recently](#) Tim was diagnosed with a very serious, very aggressive form of brain cancer."

Schilling also shared that Stacy has cancer as well.

"Tim's wife Stacy is one of the sweetest women you'll ever meet, is very sick with pancreatic cancer and my wife has talked with her and they're communicating and they're going through an incredibly difficult time with Stacy, and I wanted them to know that we're obviously all thinking of them and praying for her."

Feb. 2024 – Millen, GA – Keith & Allison Wise were both diagnosed with Stage 3 cancers at virtually the same time, in August 2022.

Two years ago this couple was diagnosed with stage 3 cancers at virtually the same time.

Allison is 65, newly diabetic (due to the RCC) with high blood pressure and is visually impaired. In August of 2022 she was diagnosed with Renal Cell Carcinoma (RCC) which required removal of her right kidney followed by a year of immunotherapy with Keytruda to treat the cancer but she is left with stage 3 kidney disease and needs specific care under a Nephrologist (Kidney Specialist).

Unable to drive or work she has been denied disability because she is married.

Keith is 62, has been through Chemo/Radiation (30 sessions, 5 days a week for 6 weeks) treatments and 4 and a half months of additional Chemotherapy to treat stage 3 Colo-rectal cancer.

Early this morning, December 4, my sister Susie died. She collapsed and EMTs were unable to revive her.

Unbeknownst to most people, Susie had a diagnosis of breast cancer right before her husband Rob passed away. She underwent a single mastectomy and radiation. On top of all that, she had been struggling with interstitial cystitis for years.

Update 3/19: It is the saddest duty of my life to report that Rob has passed away. He slept through the night peacefully, and simply stopped breathing at 8:00 am. His father was able to make it in time from Baltimore, as did his father-in-law from Southern California. I know his many, many friends and colleagues are devastated at this news.



My father went to visit Rob and Susie on the anniversary of Rob's death, March 19. When he returned the next day, Susie's name and dates had been added beneath Rob's. It is eerily similar to the way Susie just *happened* to be visiting Rob's grave on the day his headstone was first placed. I am especially fond of my input to the headstone-- "Rob" and "Susie," the names both of them went by for most of their lives, was added to the back, above "Married September 25, 1999."

You would think that, as administrator of her estate, I would be used to seeing my sister's name in the "deceased" column. But there is something about seeing her name, literally carved in stone, that breaks me.

Susan Ashworth Bader, freelance journalist and former Editor-in-Chief of TV Technology, a broadcast industry trade publication, died suddenly on December 4 at her

home in Oakland, CA. She was 52. Compassionate and curious, Susie, as she was known by family, friends and colleagues, was drawn to reporting at an early age. With no school newspaper at Serrano High School, she instead worked on the yearbook. At UC Riverside, she covered campus events from basketball to student body governance meetings for the Highlander. After graduation, she was accepted at the Medill School of Journalism at Northwestern University to obtain her Masters Degree. There it was crystallized in her, the core journalistic standards of accuracy, transparency and accountability, which she fiercely held herself and other journalists to throughout her career. During her last quarter at school, with Montana, her cat in tow, Susie moved to Washington, D.C., to continue her studies through assignments covering breaking news events in the nations capital. She met her future husband, Rob Bader, in Gaithersburg, MD. She first began working for TV Technology where she reported on advances in the field of broadcast television, from the newest flying cameras filming the X-Games to virtual reality TV news studios and even "how that elusive yellow first-down line appears on a football field". Susie and Rob were married in her hometown of Wrightwood, CA, in 1999. They moved to the Bay Area when Rob was accepted in law school at UC College of the Law in San Francisco. Susie worked for the housing publication Hanley Wood as

A pair of newlyweds have said their baby is the 'one shining light' after they were both diagnosed with cancer in the same year their daughter was born. This time last year Matt and Laura Lambert, from Derby, were looking forward to getting married and welcoming their first child in the spring.

But in February their world came crashing down when Matt, who had visited hospital several times over the previous two years with "excruciating" abdominal pains, was diagnosed with a rare type of stomach cancer called neuroendocrine tumours.

The couple, who have been together for 15 years and work in software, did not let the bad news ruin their life plans, and eloped to Las Vegas in March. Two months later their daughter, who they do not wish to name, was born, but after giving birth, Laura kept coughing and experiencing temperatures and night sweats.

She said doctors initially thought these were postpartum symptoms before a chest X-ray in November revealed Laura, 38, had a 15cm mass in her chest cavity which was stage 3 lymphoma – blood cancer. Matt, 42, is scheduled to have an operation to remove his tumours in February, and Laura will start "intensive chemotherapy" before Christmas, but the pair are concerned about losing their home if they can no longer work and cover the mortgage repayments.



Sep. 2023 – Cleveland, OH – Shane Gray was diagnosed with advanced stage testicular cancer in Feb. 2023. Months later, his wife Morgan Gray was diagnosed with triple negative breast cancer in July 2023.

Just months later, in February this year, Shane was **diagnosed with testicular cancer** that had spread to his surrounding lymph nodes. This kicked off extensive rounds of treatment including surgery and 21 chemo infusions. Thankfully he was told in June that he was cancer free.

The joy was short lived because just a few "short weeks later", Morgan was diagnosed with triple negative breast cancer, a type of breast cancer that develops more often in women under 40. The diagnosis was made during a breast examination.

The fundraiser states: "While the initial thought was that everything was fine, an ultrasound and biopsy were performed to rule anything out. The finding was yet another blow to the Gray family: Morgan had triple negative breast cancer."

'Miracle' baby born to Evesham couple diagnosed with cancer

A baby born to a couple who both had chemotherapy during the pregnancy has been described as a miracle.

James Jefferson-Loveday was diagnosed with Hodgkin lymphoma last December, just months before his wife Bethany was diagnosed with a similar cancer at 21 weeks pregnant.

His diagnosis had led to the couple from Worcestershire trying for a baby.

After treatment, baby Heidi was born healthy, while both parents are now in remission, doctors say.

Dr Salim Shafeek, who treated the couple from Evesham, said: "The combination of being pregnant and having high-grade non-Hodgkin lymphoma is exceptionally rare, and Bethany is the first case of this I've treated in my 25 years as a consultant haematologist."

Mrs Jefferson-Loveday began feeling unwell during her first trimester, while her husband was still undergoing chemotherapy treatment for his lymphoma.

She put how she was feeling down to her pregnancy and believed a lump she had found was a cyst.

Eventually seeking medical help, she was then told the devastating news.

"I will never forget the moment I was given my diagnosis," Mrs Jefferson-Loveday said.

"I remember questioning how this was possible as my husband was undergoing treatment for Hodgkin lymphoma at the time."

She talked through all treatment options with a consultant obstetrician at Worcestershire Royal Hospital before enduring an intense course of six cycles of chemotherapy, the hospital trust said.

Dr Shafeek said they could not use stronger treatment, or delay chemotherapy, which had to be finished by 35 weeks to enable her to recover enough for childbirth.

"After every chemotherapy I felt a sense of celebration that I had another one under my belt and was closer to having my baby," she said.

July 2022 – 43 year old Shauna Ellis was diagnosed with breast cancer in May 2021. Her husband, 47 year old Jason Ellis was diagnosed with Stage 3 Colon Cancer in Feb. 2022.

Shauna Ellis underwent her last surgery to treat breast cancer this Valentine's Day.

Ellis, 43, had been diagnosed with breast cancer in May 2021. Her husband Jason and two teenage kids supported her as she underwent a double mastectomy to remove both breasts.

But Shauna's final surgery did not end the Ellis family's battle with cancer. On February 16 doctors found a mass in Jason's, 47, abdomen that turned out to be stage 3 colon cancer.

In one year, Jason and Shauna Ellis went from being the self-described life of the party with plans to renew their vows in Jamaica to bedridden and weak from surgeries and chemotherapy.

"It's just a shock, it was like time stood still for both of us," Shauna Ellis told Insider. "Because literally I'm still recovering. And now he has to endure chemotherapy."

March 2022 – Michigan couple diagnosed with cancer within days of each other. Mariah

Nelesen, age 23, was diagnosed with Ovarian Cancer in Jan. 2022. Just 8 days later, her husband, Clay Sleek, age 24, was diagnosed with Acute Myeloid Leukemia.
