By Aug. 2022, Estelle was diagnosed with stage 4 cancer. How? Estelle explains in her words:

I just turned 34 and live in the SF Bay Area with my two dogs and husband. Prior to the 😞 I worked at a San Francisco tech company. I was a young 33 year old who was having fun every weekend with their friends, family, and husband. We were married in March of 2022 and I was diagnosed with stage 4 cancer by August 2022. To say our first year of marriage has been a wild ride would be an understatement.

We honeymooned in Bora Bora in March 2022 where the 🦠, or the 📌, was required within the last 9 months. We live in an area where to do absolutely anything, you needed to be 😞'd. I went back and forth on the decision but ultimately gave into social pressures to be around family, friends, attend concerts, restaurants, go to my office, go on our honeymoon, etc. I wish I listened to my gut instinct.

I share my story because I've been a healthy person for 33 years who has had nothing more than a cold and a trip to urgent care. I'm now fighting for my life suffering from stage 4 cancer - adenoid cystic carcinoma (ACC) which is normally a slow growing cancer that is growing at a rapid pace.

Since then, I've also been diagnosed with myocarditis, and am fully paralyzed from the waist down due to nerve damage from the cancer.

If the above post isn't clear, Estelle was questioning whether to get the Pfizer COVID-19 vaccine booster shot in March 2022 to be able to honeymoon in Bora, Bora.

She eventually "gave into social pressure to be around family, friends, attend concerts, restaurants, go to my office, go on our honeymoon".

The backstory starting with first two Pfizer COVID-19 vaccines is:

I've now been told that I have 2-6 months to live and that I have no options remaining at my hospital, UCLA. We will be going out of network for an experimental drug as a last resort to save my life.

The only thing that has changed in my healthcare leading up to all of this was receiving the 🦠 😞. Here's my story:

The first and second 😞 in April and May of 2021 made me very sick. I had flu like symptoms - sweating, aches and pains, severe headaches. I was in bed for 2 days after the first 😞. I also experienced other side effects including:

- Longer periods (from 30 days to 40 days)
- Clots in my periods

In September of 2021, I lost full hearing in my right ear. I went to an ENT twice and was told I had a ruptured ear drum and water on the ear. I started getting severe headaches and migraines, as well.

I also started having a lot of mental health issues. I knew something was wrong in my head and asked my mother in law to take me to a hospital because something wasn't right. I was diagnosed by a psychologist with Borderline Personality Disorder and put on antidepressants. Something friends and family who've known me forever couldn't believe. I'm now convinced it was the tumors in my brain causing this behavior.

Over the summer of 2022, the headaches continued and were getting worse, but I blamed the heat and Lexapro. Finally on 7/26/22, I woke up with a headache I couldn't ignore and doubled blurry vision in my right eye. We went to the ER and after a ton of tests, scans, etc. a hospital in Palm Desert, CA diagnosed me with a benign 2cm brain tumor which was later confirmed by UCSF to actually be stage 4 ACC. It started in the nasal pharynx and spread to the entire right side of my head and down my spine. Before treatment, we decided to do a round of IVF and freeze our embryos as we are ready to become parents.

In July 2022 (4 months after her Pfizer COVID-19 mRNA booster shot) she was diagnosed with ACC = Adenoid Cystic Carcinoma (salivary gland cancer), Stage 4.

Since my cancer was supposed to be slow growing, I was put on a treatment plan of a chemo type pill (LevatinB) and radiation that would start in September 2022 as UCSF was severely backed up with cancer patients. Before September could come, I began having severe head and neck pain to the point where I could not move. We went to the ER where they ran more tests and scans and within 3 weeks, a brand new tumor had grown on my brain stem. The size of this tumor would normally take 10-15 years to grow. All of the doctors and medical teams are in shock at how fast my "slow growing" cancer is growing.

I was admitted to the hospital on 9/29/22 and we immediately started intense radiation on my head, brain stem, neck, etc. (every location, except the spine) for 6 weeks, in addition to the chemo pill. By October, we saw amazing progress with radiation. The tumors in my head/neck/spine had shrunk at around 50% and we were hopeful it would continue - it did.

In mid October 2022, I started having excruciating back pain. Knowing that I have cancer in my spine, I begged and cried to my oncology team for scans and treatment, but they were so backed up, the soonest I could get in was December 2022.

Finally on in mid November 2022, after no success with my oncology team, I went to the ER for my back pain/spine cancer requesting a scan. They ran tests and scans and as suspected, the cancer in my spine had spread to 2 news spots, as well as my lungs. Treatment was then scheduled for January.

At the end of November I had a full blown episode of myocarditis in my home (legs shaking and collapsing to the ground). We rushed to UCSF ER where I was in the ICU for 12 days. The ICU was nothing like I ever experienced before and there was a near death "full code" experience as my lungs were filling up with fluid from the myocarditis. They didn't think I was going to make it out alive, but I did.

What happened in 2023:

I went on to start 5 rounds of radiation on my spine and 5 rounds of 2 types of traditional chemo in January 2023 which made me very sick. During this time period, I also made the choice to transfer to UCLA as I wasn't getting appropriate care through UCSF. They left my spine untreated for months despite my requests.

In March 2023, I started having more back pain and went to the ER. It was confirmed to be spreading and that we needed more radiation/treatment. By the time an appointment became available, my doctor told me that I would soon be paralyzed from permanent nerve damage in my spine because the spine was left untreated for so long. Sure enough, 1 week later I began to lose feeling below my waist and was fully paralyzed. Since then, it's been diapers catheters, a wheelchair, desitin, diaper rash, etc. I am fully paralyzed from the waist down.

I was given the news by my doctor today that UCLA has run out of treatment options for me and that I have 2-6 months to live. I'm not giving up and will keep fighting by looking at out of network options.

Like others, I share my story for awareness. I went 33 years being healthy and since getting the 😞, was diagnosed with stage 4 cancer that should be slow growing but is growing aggressively - in addition to developing myocarditis. Listen to your gut and question everything.





My Take...

These are very difficult stories to write about.

An Epoch Times journalist contacted me a few days ago and she said: “Dr.Makis, you’re an expert on turbo cancers, how do COVID-19 vaccines cause turbo cancers?”

I gave her a very long answer. Once her article is published and has been given its due, I will write a substack about it.

I don’t consider myself an expert, but corrupt and incompetent Oncologists around the world won’t do their damn job, so it’s left to me to do this.

Here are the key elements and lessons of this tragic case:

- From Pfizer COVID-19 booster shot to Stage 4 cancer diagnosis was 4 months.This is a pattern that I’ve noticed in many cases, 3-4 months post jab until Stage 4 cancer diagnosis. Similar timeline as the case of 12 year old Alrence Qunitana and his post Moderna mRNA vaccine brain cancer that I wrote about ([click here](#))
- Extensive cancer spread upon diagnosis (“started in the nasal pharynx and spread to the entire right side of my head and down my spine”) – Stage 4.
- Extremely rapid growth (“size of this tumor normally takes 10-15 years to grow”)
- Shocked oncologists (“all of the doctors and medical teams are in shock at how fast my “slow growing” cancer is growing”). These are supposed to be “experts”.
- Extremely rapid spread – her oncologists couldn’t keep up with the tumor spread which spread to the spine and paralyzed her from the waist down by March 2023
- Resistant to chemotherapy and radiation therapy – she had both. Didn’t work.
- Oncologists have nothing to offer to treat turbo cancer because they don’t

understand it (“I was given the news by my doctor today that UCLA has run out of treatment options for me and that I have 2-6 months to live”).

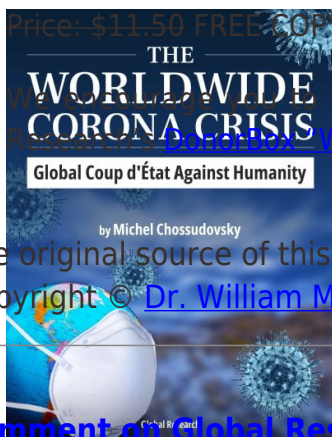
