This letter is in response to your Centers for Disease Control and Prevention and Agency for Toxic Substances and Disease Registry (CDC/ATSDR) Freedom of Information Act (FOIA) request of July 16, 2024 (request attached).

A search of our records failed to reveal any documents pertaining to your request. Subject-matter experts in the Coronavirus and Other Respiratory Viruses Division (CORVD) were tasked with this FOIA and they provided the following information:

"We do not have any responsive records, because none of the methods in the request for information have been used for SARS-CoV-2 sequencing.

Our sequencing staff have specified that:

- 1. We do not have records on single virion sequencing that ensured the virion was physically isolated from any other genetic material before sequencing. Sequencing was only on clinical specimens or unpurified virus isolate material (lysate or supernatant). We do not have methods to purify a single virion away from all other materials.**
- 2. We do not have single read sequences. cDNA synthesis limits length and we utilize amplicons with informatic assembly, therefore we do not have responsive records for this specific request.**
- 3. We don't have any record in request regarding SARS-CoV-2 (GenBank: MN908947.3) and RaTG13 (GenBank: MN996532.2) although (1) both SARS-CoV-2 (GenBank: MN908947.3) and RaTG13 (GenBank: MN996532.2) sequences were downloaded from public domains for phylogeny analysis and SARS-CoV-2 (GenBank: MN908947) sequence was referenced for genome-walking primer design.**
- 4. We have never utilized 5' RACE methodology. We had the Wuhan-u-01 sequence from a public database to guide primer design of the genome."**

**You...
Locked down for nothing. Masked up for nothing.

There is no other stance possible and the sooner people grasp this reality, the sooner we can bring an end to this nightmare. Those like Robert Kennedy Jr. who make some vague suggestions that something was not right, and can be solved by future laws and regulations, are not doing anyone any favors except the billionaires whom he counts among his closest friends.
