I post the whole hearing with Pfizer's representative so everybody can see the context and everything that was asked and answered.

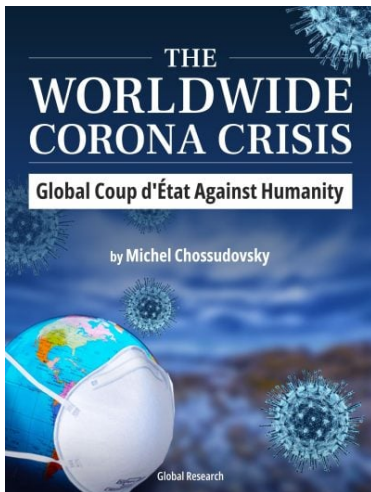
