Yet cannabis remains a Schedule I controlled substance (“a deadly dangerous drug with no medical use and high potential for abuse”), illegal to be sold or grown in the US.”*

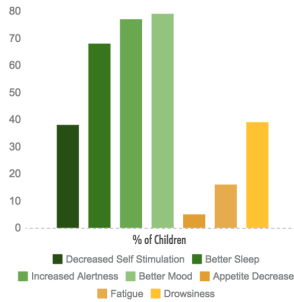


For every 1000 residents, 5 are cannabis patients

## Medical Benefits

Medical Properties	Effects
Antiemetic	Reduces nausea and vomiting
Anticonvulsant	Suppresses seizure activity
Antipsychotic	Combats psychosis disorders
Anti-inflammatory	Combats inflammatory disorders
Anti-oxidant	Combats neurodegenerative disorders
Anti-tumor/Anti-cancer	Combats tumor and cancer cells
Anxiolytic/Anti-depressant	Combats anxiety and depression disorders

## CANNABIDIOL

CBD is among the most prominent of the more than 85 cannabinoids found in cannabis. Unlike the well-known psychoactive cannabinoid tetrahydrocannabinol (THC), CBD is not psychoactive and therefore doesn't cause users to experience a high.

### What is it?

- Most exciting cannabinoids - natural compound found in cannabis
- a potential breakthrough nutritional component and treatment
- found throughout the seeds, stalk and flowers of cannabis plants — including hemp and marijuana.
- occurs naturally in significant quantities in cannabis, so it is relatively easily extracted

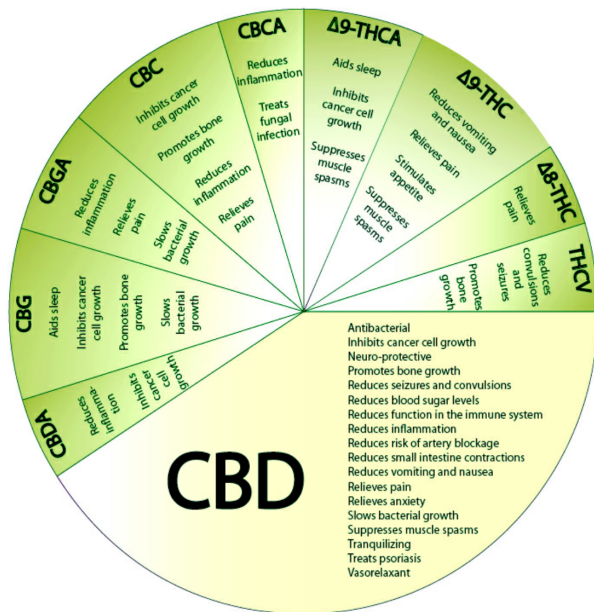
### Where it is found?

- Naturally, in the cannabis plant.
- found in both hemp and marijuana varieties of cannabis.
- also produced synthetically in a laboratory

### Illegal?

- remains illegal in many parts of the world.
- classified as a Schedule I drug in the United States and a Schedule II drug in Canada.
- U.S. Food and Drug Administration recently approved a request to trial a pharmaceutical version of CBD in children with rare forms of epilepsy.
- A patent awarded to the U.S. Health and Human Services in 2003 (US6630507) also covers the use of CBD as a treatment for various neurodegenerative and inflammatory disorders.
